TERMS AND CONDITIONS OF ENTRY – MEMBERSHIP APPLICATION – INDEMNITY FORM

FASTKARTS (A.C.N:621 561 911) T/A FASTKARTS Agrees to hire to the hirer whose name, address and signature appears below and to permit the Hirer to use the Karts, services and facilities upon the terms and conditions herein after appearing.

The Hirer:

- 1. Agrees that the driving of go karts is inherently dangerous and may lead to injury or death. The hirer voluntarily agrees to accept all risks and danger, prior to, during and subsequent driving of the go-karts, including damage or injury caused by other drivers.
2. Agrees to use FASTKARTS services and facilities or occupy the premises and surrounds of FASTKARTS approved venue within Queensland and any part of it at their own risk and release to the full extent as permitted by law, FASTKARTS, and it's staff, agents, invitees and licensees of FASTKARTS and each of them from all liabilities whatsoever arising (including but not limited to any negligence or breach of control) resulting from any accidents, loss, damage or injury to the hirer or its staff, agents, sub-contractors, invitees, licensees or permittees.
3. The Hirer by this agreement indemnifies FASTKARTS and agrees to keep FASTKARTS always indemnified in respect of all loss, damage, subsequent loss and damage claimed by any person against FASTKARTS and legal fees or consultants fees which FASTKARTS may suffer or incur and all money which FASTKARTS may become liable to pay any person in respect of or arising directly or indirectly out of any act, default or omission on the part of the Hirer or it's, his or her employees, servant, agents, invitees, licensees and/or permittees.
4. Agrees to abide by all rules, regulations and warnings (both written and oral) established by FASTKARTS from the time regarding the use and facilities and services of FASTKARTS and shall comply with all lawful directions of FASTKARTS as given and use, as directed, all safety equipment provided.
5. Grants permission to FASTKARTS and their agents to utilise the hirers image or likeness incidental part, in any way which FASTKARTS or such authorised person sees fit.
6. Hirer has a duty to act with good judgement and consideration for themselves and others and to refrain from BEHAVIOUR THAT EFFECTS THE SAFETY OF THEMSELVES AND OTHERS or the Karts themselves and act in a responsible manner whilst using the facility and on the premises.
7. Agrees management accepts no responsibility or liability or any personal property brought to, or left on site. Hirer can use own safety equipment at own risk.
8. Agrees that FASTKARTS may for any reason whatsoever terminate this agreement and require the hirer to leave the premises when directed to do so.
9. Agrees that they have zero alcohol or drugs in their system at any time during any hire
10. The expression "the hirer" shall mean the hirer or that referred to herein and his legal personal representative.
11. Hirer acknowledges they understand/ or have interpreted for them the basic language of english for safety communication purposes.
